### LYOPHILISATE FOR SUSPENSION FOR INJECTION AND SOLVENT

PESTDOLL-S is a live attenuated lyophilized vaccine prepared in vero cell cultures against peste des petits ruminants (PPR) disease of goats and sheep.

#### VACCINE COMPOSITION:

Each dose of vaccine contains at least:

Attenuated PPRV 75/1	$10^3$ TCID <sub>50</sub> /dose
Lactalbumin hydrolysate	0,25 mg/dose
Sucrose	0,50 mg/dose

#### INDICATIONS:

It is used for protection of sheep and goats against Peste des Petits Ruminants disease.

#### CONTRAINDICATIONS:

No contraindications. It is safe to be used in all ages and pregnant animals.

#### WARNINGS:

Cold chain conditions must be ensured during vaccine transportation and administration, the lyophilized vaccine should be reconstituted using a sterile syringe after the solvent have cooled. Dissolved vaccines should thoroughly be mixed in the solvent, and the reconstituted vaccine should be shaken well each time the vaccine is drawn into the syringe. Asepsis and antisepsis principles should be followed during administration. Reconstituted vaccines should not be exposed to direct sunlight and if possible, should be kept in ice. The reconstituted vaccine should be used within two hours at the latest. Disinfectants and antiseptics should never be used for the sterilization of injectors used in vaccination.

#### METHOD OF ADMINISTRATION AND DOSAGE:

1 ml by subcutaneous axillary injection.

#### VACCINATION SCHEDULE:

Protective immunity in vaccinated animals occurs in 21 days. Kids and lambs born from immune animals can be vaccinated at the age of 4-6 months.

#### STORAGE CONDITIONS:

The lyophilized vaccine is store at + 2/8°C, and in the dark.

#### PRESENTATION:

Glass vials of 50 and 100 doses of lyophilized pellet, 20 pieces of which in a plastic tray or in styrofoam with or without a box: Brown glass or plastic bottles of 50 and 100 ml solvent in boxes of 100.

#### DISPOSAL METHOD:

Reconstituted but not used vaccines are disposed of by boiling for 10 minutes. Unused lyophilized vaccines are returned to the producer.
